SECTION 4: First aid measures

4.1. Description of first aid measures

Inhalation:

5.3. Special protective actions for fire-fighters

Water may not effectively extinguish fire; however, it should be used to keep fire-exposed containers and surfaces cool and prevent explosive rupture. 6.2. Environmental precautions
