This tape is designed for use with 3M-Matic™ CTS stands and other 3M-Matic™ case sealing equipment. Application of Scotch® Taping System Tape 3781 is most easily accomplished at room temperature because at colder temperatures, approaching 32°F (0°C), the adhesive becomes more firm. Once applied, Scotch® Tape 3781 performs well throughout the normal temperature ranges typically encountered by packaged products in shipping and storage environments.

Storage and Shelf Life

Store under normal conditions of 4° to 27°C (40° to 80°F) and 40 to 50% relative humidity in the original packaging, out of direct sunlight. For best performance, use this product within 24 months from date of manufacture.
