

These tapes are designed for use with 3M-Matic™ CTS stands and other 3MMatic™ case sealing equipment. Application of Scotch® Performance Continuous Taping System Tapes 3782 and 3785 is most easily accomplished at room temperature. At colder temperatures, approaching 32°F (0°C), the adhesive becomes more firm. Once applied, the tapes perform well throughout the normal temperature ranges typically encountered by packaged products in shipping and storage requirements.
